WHEREAS, on the 4th day of October, 2021, the City of University Heights enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of resurfacing Cedar Road (C.R. 23) between South Taylor Road and Fenwick Road and between Miramar Boulevard and South Green Road, including pavement repair, bus pad repair, curb, sidewalk, curb ramps, casting adjustments, signage, pavement markings, and pedestrian signals, lying within the City of University Heights; and

WHEREAS, the City shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the city limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation.

WHEREAS, the City's share of the cost is now estimated in the amount of One Million Twenty-Nine Thousand Five Hundred Six and 00/100 Dollars (\$1,029,506.00), but said estimated amount is to be adjusted in order that the City's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined;

WHEREAS, the Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this Council; and

WHEREAS, the City desires the Director of Transportation to proceed with the aforesaid highway improvement;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF UNIVERSITY HEIGHTS, CUYAHOGA COUNTY, OHIO, THAT:

Section 1: The estimated sum of One Million Twenty-Nine Thousand Five Hundred Six and 00/100 Dollars (\$1,029,506.00) is hereby appropriated for the improvements described above and the Finance Director is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds.

Section 2: The City hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

<u>Section 3</u>: The City shall enter into a contract with the State of Ohio, and that Mayor is hereby authorized to execute said contract in the form attached hereto as Exhibit A, which is incorporated herein by reference as if fully rewritten, providing for the payment by the City of the sum of money set forth herein above for improving the described project.

<u>Section 4</u>: The City shall transmit to the Director of Transportation a fully executed certified copy of this Ordinance.

<u>Section 5</u>: The Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, that all deliberations of this Council and of its committees, if any, which results in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements, including Section 121.22 of the ORC.

<u>Section 6</u>: This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, so the City can meet the deadline for submitting this ordinance to the Ohio Department of Transportation; wherefore, this ordinance shall be in full force and effect from and immediately after its adoption and approval by the Mayor.

CONTRACT

(Chapter 5521, Ohio Revised Code)

This contract is made by and between the State of Ohio, Department of Transportation, acting through its director (hereinafter referred to as the "STATE"), 1980 West Broad Street, Columbus, Ohio 43223, and the City of **University Heights**, (hereinafter referred to as the legislative authority/Local Public Agency or "LPA").

WITNESSTH:

WHEREAS, Chapter 5521 of the Ohio Revised Code provides that the legislative authority may cooperate with the STATE in a highway project made by and under the supervision of the Director of Transportation; and

WHEREAS, through the enactment of preliminary legislation, the LPA and the STATE have agreed to cooperate in the highway project described below; and

WHEREAS, through the enactment of final legislation, the LPA has committed to pay an estimated amount of money as its share of the total estimated cost and expense of the highway project described below; and

WHEREAS, the fiscal officer of the LPA has filed with the LPA a certificate stating that sufficient moneys are available, as required by Chapter 5521 and Section 5705.41 of the Ohio Revised Code. A duplicate certificate is attached hereto; and

WHEREAS, in accordance with the final legislation, the LPA hereby enters into this contract with the STATE to provide for payment of the agreed portion of the cost of the highway project and any additional obligations for the highway project described below.

NOW, THEREFORE, in consideration of the premises and the performances of mutual covenants hereinafter set forth, it is agreed by parties hereto as follows:

SECTION I: RECITALS

The foregoing recitals are hereby incorporated as a material part of this contract.

SECTION II: PURPOSE

The purpose of this contract is to set forth requirements associated with the highway project described below (hereinafter referred to as the "PROJECT") and to establish the responsibilities for the administration of the PROJECT by the LPA and the STATE.

SECTION III: LEGAL REFERENCES

This contract is established pursuant to Chapter 5521 of the Ohio Revised Code.

SECTION IV: SCOPE OF WORK

The work to be performed under this contract shall consist of the following:

The project consists of resurfacing Cedar Road (C.R. 23) between South Taylor Road and Fenwick Road and between Miramar Boulevard and South Green Road, including pavement repair, bus pad repair, curb, sidewalk, curb ramps, casting adjustments, signage, pavement markings, and pedestrian signals, lying within the City of University Heights.

SECTION V: FINANCIAL PARTICIPATION

- 1. The STATE agrees to provide the necessary funds as enumerated in this section and allowed by law for the financing of this project.
- 2. The STATE may allocate the money contributed by the LPA in whatever manner it deems necessary in financing the cost of construction, right-of-way, engineering, and incidental expenses, notwithstanding the percentage basis of contribution by the LPA.
- 3. The total cost and expenses for the project are only an estimate and the total cost and expenses may be adjusted by the STATE. If any adjustments are required, payment of additional funds shall correspond with the percentages of actual costs when said actual costs are determined, and as requested, by the Director of Transportation.
- 4. The LPA agrees to pay to the STATE its share of the total estimated cost expense for the above highway project in the amount of **One Million Twenty-Nine Thousand Five Hundred Six and - 00/100 Dollars, (\$1,029,506.00)**.
- 5. The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the city limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U. S. Department of Transportation.
- 6. The LPA agrees to assume and bear One Hundred Percent (100%) of the cost of any construction items required by the LPA on the entire project, which are not necessary for the improvement, as determined by the State and Federal Highway Administration.
- 7. The LPA agrees that change orders and extra work contracts required fulfilling the construction contracts shall be processed as needed. The STATE shall not approve a change order or extra work contract until it first gives notice, in writing, to the LPA. The LPA shall contribute its share of the cost of these items in accordance with other sections herein.

SECTION VI: RIGHT-OF-WAY AND UTILITIES

- The LPA agrees that all right-of-way required for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.
- 2. The LPA agrees that all utility accommodation, relocation, and reimbursement will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual, including that:
 - A. Arrangements have been or will be made with all utilities where facilities are affected by the described PROJECT, that the utilities have agreed to make all necessary removals and/or relocations to clear any construction called for by the plans of this PROJECT, and that the utilities have agreed to make the necessary removals and/or relocations after notification by the LPA or STATE.
 - B. The LPA shall, at its own expense, make all removals and/or relocations of publicly-owned utilities which do not comply with the reimbursement provisions of the ODOT Utilities Manual. Publicly-owned facilities which do comply with the reimbursement provisions of the ODOT Utilities Manual will be removed and/or relocated at project expense, exclusive of betterments.
 - C. The removals and/or relocation of all utilities shall be done in such a manner as not to interfere with the operation of the contractor constructing the PROJECT and that the utility removals and/or relocations shall be approved by the STATE and performed in accordance with the provisions of the ODOT Construction and Materials Specifications.

SECTION VII: ADDITIONAL PROJECT OBLIGATIONS

- 1. The STATE shall initiate the competitive bid letting process and award the PROJECT in accordance with ODOT's policies and procedures.
- 2. The LPA agrees:
 - A. To keep said highway open to traffic at all times;
 - B. To maintain the PROJECT in accordance with the provisions of the statutes relating thereto,
 - C. To make ample financial and other provisions for such maintenance of the PROJECT after its completion;
 - D. To maintain the right-of-way and keep it free of obstructions in a manner satisfactory to the STATE and hold said right-of-way inviolate for public highway purposes;

- E. To place and maintain all traffic control devices conforming to the Ohio Manual of Uniform Traffic Control Devices on the project in compliance with the provisions of Section 4511.11 of the Ohio Revised Code;
- F. To regulate parking in accordance with Section 4511.66 of the Ohio Revised Code, unless otherwise controlled by local ordinance or resolution.

SECTION VIII: DISPUTES

In the event that any disputes arise between the STATE and LPA concerning interruption of or performance pursuant to this contract, such disputes shall be resolved solely and finally by the Director of Transportation.

SECTION IX: NOTICE

Notice under this contract shall be directed as follows:

SECTION X: FEDERAL REQUIREMENTS

- 1. In carrying out this contract, LPA shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, national origin, disability, or age. LPA will ensure that applicants are hired and that employees are treated during employment without regard to their race, religion, color, sex, national origin (ancestry), disability, genetic information, or age (40 years or older), sexual orientation, or military status (past, present, future). Such action shall include, but not be limited to, the following: Employment, Upgrading, Demotion, or Transfer; Recruitment or Recruitment Advertising; Layoff or Termination; Rates of Pay or other forms of Compensation; and Selection for Training including Apprenticeship.
- 2. To the extent necessary under Ohio law, LPA agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the provisions of this nondiscrimination clause. LPA will, in all solicitations or advertisements for employees placed by or on behalf of LPA, state that all qualified applicants will receive consideration for employment without regard to race, religion, color, sex, national origin (ancestry), disability, genetic information, age (40 years or older), sexual orientation, or military status (past, present, future). If applicable, the LPA shall incorporate the foregoing requirements of this paragraph in all of its contracts for any of the work prescribed herein (other than subcontracts for standard commercial supplies or raw materials) and will require all of its subcontractors for any part of such work to incorporate such requirements in all subcontracts for such work.

3. LPA agrees to fully comply with Title VI of the Civil Rights Act of 1964, 42 USC Sec. 2000. LPA shall not discriminate on the basis of race, color, or national origin in its programs or activities. The Director of Transportation may monitor the Contractor's compliance with Title VI.

SECTION XI: GENERAL PROVISIONS

- 1. This contract constitutes the entire contract between the parties. All prior discussions and understandings between the parties are superseded by this contract.
- Neither this contract nor any rights, duties or obligations described herein shall be assigned by either party hereto without the prior express written consent of the other party.
- 3. Any change to the provisions of this contract must be made in a written amendment executed by both parties.
- 4. This contract and any claims arising out of this contract shall be governed by the laws of the State of Ohio. Any provision of this contract prohibited by the law of Ohio shall be deemed void and of no effect. Any litigation arising out of or relating in any way to this contract or the performance thereunder shall be brought only in the courts of Ohio, and the LPA hereby irrevocably consents to such jurisdiction. To the extent that the STATE is a party to any litigation arising out of or relating in any way to this contract or the performance thereunder, such an action shall be brought only in a court of competent jurisdiction in Franklin County, Ohio.
- 5. All financial obligations of the State of Ohio, as provided in this contract, are subject to the provisions of Section 126.07 of the Ohio Revised Code. The financial obligations of the State of Ohio shall not be valid and enforceable unless funds are appropriated by the Ohio General Assembly and encumbered by the STATE. Additionally, it is understood that this financial obligation of the LPA shall not be valid and enforceable unless funds are appropriated by the LPA's legislative body.
- 6. This contract shall be deemed to have been substantially performed only when fully performed according to its terms and conditions and any modification thereof.
- 7. LPA agrees that it is currently in compliance and will continue to adhere to the requirements of Ohio Ethics law as provided by Section 102.03 and 102.04 of the Ohio Revised Code.

SECTION XII: SIGNATURES

Any person executing this contract in a representative capacity hereby warrants that he/she has been duly authorized by his/her principal to execute this contract on such principal behalf.

ORDINANCE 2022 - 12

INTRODUCED BY: MAYOR BRENNAN

AN ORDINANCE PROVIDING FOR SUBMISSION TO THE ELECTORS OF THE CITY OF UNIVERSITY HEIGHTS A PROPOSED AMENDMENT TO THE CHARTER TO AMEND ARTICLE 3 SECTION 5 RELATING TO COUNCIL PROCEDURE, TO PROVIDE THAT COUNCIL MEETINGS AND OTHER **MEETINGS HELD** PUBLIC CAN \mathbf{BE} LIVE TELECONFERENCE, VIDEOCONFERENCE OR SIMILAR TECHNOLOGIES, AND **EXECUTIVE** PROVIDING FOR SESSIONS WITH LEGAL COUNSEL, AND DECLARING AN **EMERGENCY**

WHEREAS, Article 8, Section 5 of the City of University Heights Charter provides Council, upon approval of at least five (5) members, with the authority to submit proposed changes to the City Charter for consideration by the electorate; and

WHEREAS, Council wishes to amend the City Charter to provide for meetings to be held virtually, when necessary for health or safety reasons;

WHEREAS, nothing herein shall be construed to be in conflict with the "in person" attendance requirement for members of a public body, who must appear in person for purposes of quorum and to vote at any such meeting;

WHEREAS, this Council finds and determines that it is in the City's best interest to submit to electors of the City of University Heights the proposed amendment to the Charter as herein above summarized; and

WHEREAS, this Council chooses the date of May 3, 2022 for the election of the Charter amendment proposal hereinafter set forth;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of University Heights, State of Ohio:

Section 1. This Council hereby authorizes and directs the submission to the electors of the City of University Heights, in an election to be held at the usual places of voting in said City, on Tuesday, May 3, 2022, of the following proposal to amend the Charter of the City as further provided below.

That existing Article 3, Section 5 be amended, in its entirety, as follows:

SECTION 5. <u>Procedure</u>. A majority of the members elected to the Council shall constitute a quorum for the transaction of business, but a less number may adjourn from time to time to compel the attendance of absent members. The Council shall keep a journal of its proceedings.

All regular and special meetings of Council and Council committees shall be publicly announced and shall be open to the public in accordance with the provisions of the Ohio "Sunshine Law" as it may be amended from time to time, presently codified at Section 121.22 of the Ohio Revised Code. Council may hold an executive session at any regular or special meeting of Council, upon the majority roll call vote of a quorum of Council, for the sole purpose of the consideration of any matter specified in Ohio Revised Code Section 121.22, as it may be amended from time to time.

All meetings of Council called for the purpose of transacting public business, where a majority of the Council members elected are present in person, shall be open to the public, which

may be by live attendance or, when permitted by law, by means of teleconference, video conference, or any other similar electronic technology, unless a provate executive session is called pursuant to the Ohio Revised Code, or a private executive session is held with the Director of Law of an assistant Director of Law.

The Council shall, by ordinance, make provision for the following:

- a. The time and place of regular meetings, providing for at least two regular meetings in each calendar month excepting the months of July and August;
- b. The manner of calling special meetings;
- c. The enforcement of attendance at its meetings and punishment of disorderly conduct thereat;
- d. The form and method of enacting ordinances and resolutions, but no ordinance or resolution except general appropriation ordinances shall contain more than one subject which shall be clearly stated in the title; and general appropriation ordinances shall be confined to the subject of appropriations;
- e. The manner of giving public notice of the enactment of ordinances and of any other of its acts or proceedings which it deems proper to publish;
- f. The reduction of unpaid installments and the return of paid installments of assessments levied in larger amounts than necessary to pay for public improvements, to the extent that such reductions and return are authorized by the general law of Ohio;
- g. The procedure for making public improvements and for levying assessments, provided that two or more public improvements, including the levying of assessments therefor, may be combined in one proceeding if the Council finds that it will be economical and practical to undertake said improvements jointly;
- h. The advertising and awarding of contracts;
- The employment of expert consultants to advise and assist city officials and employees with respect to municipal problems and such other general regulations as the Council may deem necessary;
- j. The printing, publishing and distribution of financial reports and such other reports of general interest as the Council shall determine, at City expense, providing that such reports shall be factual only and do not express an opinion or promote any person, position, group of persons, or any idea, theory or viewpoint of a political or controversial nature.
- k. Such other general regulations as the Council may deem

necessary including, but not limited to, adopting one or more ordinances to provide that all meetings of Council and its committees, and any board, commission and any other sdministrative body of the City shall be open to the public which may be by live attendance, and/or by means of teleconference, videoconference, or any other similar electronic technology, unless a private executive session is called pursuant to the Ohio Revised Code or to meet in exective session with the Director of Law or any assistant Director of Law.

<u>Section 2.</u> If the amendments set forth in Section 1 hereof are adopted, existing Charter Article 3, Section 5 shall be repealed.

<u>Section 3.</u> That the form of the ballot to be cast in the election for the proposed Charter amendments contained in Section 1 hereof shall read and provide as follows:

PROPOSED CHARTER AMENDMENT

A majority affirmative vote is necessary for passage

Shall Article 3, Section 5 of the Charter of the City of University Heights be amended to provide Council, Council committee, boards, commissions and other administrative bodies' meetings may be held live, and/or by teleconference, videoconference or similar technologies and provide for executive sessions with legal counsel?

- <u>Section 4.</u> That if such amendments are approved by a majority of the electors voting thereon as such election, such amendments so approved shall become effective on the earliest date allowed by law.
- <u>Section 5.</u> The affirmative vote of at least five (5) members of Council is necessary for passage of this Ordinance.
- <u>Section 6.</u> That the Clerk of Council is hereby directed to cause notice of the proposed Charter Amendments to be published in such manner as may be authorized by law, and as required by Article XVIII, Section 9 of the Ohio Constitution.
- <u>Section 7.</u> That the Clerk of Council is hereby directed to cause notice of this Ordinance to be published in the manner established in University Heights Codified Ordinance Section 220.17.
- **Section 8.** That the Clerk of Council be and hereby is authorized and directed to forward a certified copy of this Ordinance to the Board of Elections of Cuyahoga County.
- <u>Section 9.</u> That the Board of Elections of Cuyahoga County is hereby requested to cause appropriate notice of such election to be duly given in accordance with law.
- <u>Section 10.</u> That there is hereby appropriated from the general fund of the City an amount sufficient to pay the cost of carrying out the directions of this Ordinance, including the cost of publishing notice of such election.
- Section 11. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.
- <u>Section 12</u>. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, the emergency being the need to provide a certified copy of this Ordinance to the Cuyahoga County Board of Elections within a timeframe sufficient to allow the proposed Charter

Amendments to appear on the ballot for decision by the electors of the City of University Heights on May 3, 2022; wherefore, this ordinance shall be in full force and effect from and immediately after its adoption and approval by the Mayor. This ordinance shall take effect from and after the earliest time allowed by law.

ORDINANCE 2022 - 13

INTRODUCED BY: COUNCILPERSON GOULD

AN ORDINANCE ENACTING CODIFIED ORDINANCE SECTION 1280.13 ENTITLED "MANUFACTURE, DISTRIBUTION AND SALE OF FIREWORKS PROHIBITED"

WHEREAS, to promote the health, safety and welfare of its residents, the City wishes to prohibit the manufacture, distribution, wholesale, sale, and storage of fireworks;

WHEREAS, the City is substantially built-out and has no areas within the City that are or could be zoned for Industrial or Light Industrial Use;

WHEREAS, the City is densely populated, and commercial establishments within the City are situated in close proximity to each other and to residential areas, schools, religious institutions and common areas;

WHEREAS, due to their highly flammable and combustible nature, fireworks are best manufactured, distributed, stored and kept on large sites located a reasonable distance from densely populated and/or configured commercial areas, residential areas, schools, religious institutions and common areas;

WHEREAS, the City cannot safely accommodate the manufacture, distribution, wholesale, sale, and storage of fireworks

WHEREAS, the City wishes to enact regulations to ensure the safety of dense residential and business areas;

WHEREAS, the Council wishes to impose a complete ban on the manufacture, distribution, wholesale, and storage of fireworks;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of University Heights, State of Ohio:

<u>Section 1</u>. The Council hereby enacts Codified Ordinance Section 1280.13 entitled "Manufacture, Distribution, Storage and Wholesale of Fireworks Prohibited," which shall read in its entirety as follows:

1280.13 MANUFACTURE, DISTRIBUTION, STORAGE AND WHOLESALE OF FIREWORKS PROHIBITED.

- (a) For purposes of this ordinance, the terms "fireworks," "1.3G fireworks," "1.4G fireworks," and "fireworks plant" shall have the meanings ascribed to such terms in Ohio Revised Code Section 3743.01.
- (b) No fireworks plant shall be permitted in the City.
- (c) The manufacture, distribution, storage and wholesale of fireworks, 1.3G fireworks and 1.4G fireworks is prohibited within the City.

<u>Section 2.</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.

Section 3.	This ordinance shall take effect on the earliest date allowed by law.

A RESOLUTION OF NECESSITY DECLARING THE INTENT TO APPROPRIATE AND ACQUIRE THE FEE SIMPLE INTEREST IN CERTAIN REAL PROPERTY TITLED TO UNIVERSITY SQUARE PARKING LLC, KNOWN AS 14060 CEDAR ROAD, BEARING PERMANENT PARCEL NO. 721-01-003, CITY OF UNIVERSITY HEIGHTS, COUNTY OF CUYAHOGA, STATE OF OHIO, AS MORE FULLY DESCRIBED HEREIN, FOR THE PURPOSE OF ELIMINATING BLIGHT.

WHEREAS, City Council deems it necessary to appropriate certain property known as 14060 Cedar Road, University Heights, Ohio for the purpose of eliminating blighted property, and wishes to present the results of an appraisal of said property to the owner thereof, and wishes to present the owner thereof with a Notice of Intent to Acquire said property, and wishes for negotiations to be conducted in connection with the acquisition of same, and wishes to ratify any of the foregoing;

WHEREAS, the property (the "Property") includes a public parking facility that is part of the University Square Shopping Center development and that was originally designed to house retail businesses (the "Garage");

WHEREAS, the Garage is dark, damp, unsafe, and in need of capital improvements;

WHEREAS, the Garage has been cited by the City's Building Department and Fire Prevention Bureau for numerous building code violations;

WHEREAS, the interior spaces of the Garage are poorly maintained and include debris, overflowing trash receptacles, and built up mud, dirt and grime;

WHEREAS, the ramp leading up to the top floor of the Garage requires repair and improvement;

WHEREAS, the Property and the Garage are characterized by age and obsolescence, unsafe and unsanitary conditions, hazards that endanger lives or properties by fire or other causes, noncompliance with building and fire codes, and faulty lot layout in relation to size, adequacy, accessibility and usefulness;

WHEREAS, the Garage is significantly underutilized;

WHEREAS, the condition of the Garage adversely impacts the value of surrounding properties;

WHEREAS, it is in the interests of the health, safety and welfare of the City's citizens that the City eliminate blighted property by acquiring Permanent Parcel No. 721-01-001 located at 2203 Warrensville Center Road, University Heights, Ohio;

NOW THEREFORE BE IT RESOLVED by the Council of the City of University Heights, County of Cuyahoga, State of Ohio, that:

SECTION 1. Council hereby declares its intent to appropriate and acquire the fee simple interest in the Property to eliminate blight, and to pursue a redevelopment plan for the Property in accordance with the requirements of Ohio Revised Code Chapter 163. A legal description of the Property is attached hereto as Exhibit A, which is incorporated herein by reference as if fully re-written.

SECTION 2. Council hereby directs the Mayor or his designee to present the owner of the Property and other interested parties with a Notice of Intent to Acquire said Property, and wishes for negotiations to be conducted in connection with the acquisition of same

SECTION 3. The Clerk of Council shall mail by certified mail or personally deliver a copy of this Resolution of Necessity to the owner of the Property.

SECTION 4. Council hereby directs the Mayor or designee to send or personally deliver a Notice of Intent to Acquire to be sent to the owner of the Property, in the form required by R.C. Section 163.041.

SECTION 5. Council hereby affirms the need for the Property and wishes to proceed to acquire said Property to eliminate blight.

SECTION 6. This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

There are a variety of federal, state, and local grant funding opportunities available to the Fire Department. These opportunities support the needs of public safety in local communities.

The primary goal of the of the Fire Department seeking grant funding is to enhance the safety of the public and firefighters with respect to fire-related hazards by obtaining direct financial assistance to our department. This funding is for critically needed resources to equip and training emergency personnel to recognized standards, enhance operations efficiencies, foster interoperability, and support community resilience. Although smaller grant funding sources may have a maximum award, many federal grant opportunities do not have a maximum award. This is also indicative of matching funds in which smaller grants typical do not require matching funds and some federal grants may require 5-15% of the total request.

This year the Fire Department has historically focused on capital items that are in need of replacement or nearing its end of service life. It has been the mission of the Department to seek this funding to assist the City financially to the best of our ability. Over the last ten years the Department has secured over one million dollars, approximately. Last year alone, approximately \$100,000 was awarded in Federal and State Grant funding.

During the onset of the COVID pandemic in spring of 2020 and its uncertainty, City Council members unanimously approved a motion to allow for blanket authority to apply for grant funding as long as each itemized item awarded was brought back to Council for approval prior to accepting any funds (April 20, 2020). This approval was requested and also unanimously approved in March of 2021. This allowed the Fire Department to apply for pop-up grant assistance related to the pandemic. It also afforded the Department to participate in grant opportunities in a manner that was timelier. Each grant opportunity that was awarded last year was brought to Council for approval to accept prior to the Fire Department accepting any awards or funding.

Therefore, I am respectfully requesting the approval to apply for any grant opportunities that support the mission of the Fire Department during FY2022, as long as all awarded grants are brought to Council for approval prior to the Department accepting the award or any related funds.
