

**ORDINANCE NO. 2017-43**

**INTRODUCED BY: MAYOR AND COUNCIL AS A WHOLE**

**AN ORDINANCE AUTHORIZING A CONTRACT BETWEEN THE CITY OF UNIVERSITY HEIGHTS AND THE OHIO PATROLMEN'S BENEVOLENT ASSOCIATION (PATROL OFFICERS), SETTING FORTH THE RATE OF COMPENSATION AND BENEFITS AND CONDITIONS OF EMPLOYMENT FOR MEMBERS OF THE BARGAINING UNIT AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Council deems it necessary for the City of University Heights, Ohio, to enter into a contract with the Ohio Patrolmen's Benevolent Association (Patrol Officers), in order to set forth the rate of compensation, benefits and conditions of employment for Dispatchers in the Division of Public Safety.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF UNIVERSITY HEIGHTS, OHIO, THAT:**

**Section 1.** The City of University Heights, Ohio, shall enter into a contract with the Ohio Patrolmen's Benevolent Association (Patrol Officers), for a three (3) year period commencing July 1, 2017, in accordance with the terms attached hereto and made a part hereof.

**Section 2.** The Mayor is hereby authorized to execute said contract incorporating all of the terms and conditions agreed to by the parties and after full review and approval as to content by the City's legal counsel (law firm of Mansour, Gavin, Gerlack & Manos Co., L.P.A) and as to form by the City's Law Director.


**Section 3.** This Ordinance replaces and repeals Ordinance No. 2014-58.

**Section 4.** This Ordinance shall apply only to persons who are members of the bargaining unit as identified in the agreement and who are otherwise governed by this Ordinance.

**Section 5.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in full compliance with all legal requirements.

**Section 6.** This Ordinance constitutes an emergency measure for the immediate preservation of public peace, health and safety of the citizens of the City of University Heights, and for the additional reason that this Ordinance is necessary to provide for the orderly operations of the Police Department, and provided it receives the affirmative vote of not less than five (5) members of Council, it shall take effect immediately upon its passage and approval of the Mayor, otherwise, it shall become effective at the earliest time allowed by law.
