

RESOLUTION NO. 2018-13 A RESOLUTION HONORING BLACK HISTORY MONTH, 2018

WHEREAS, the story of African Americans is one of resilience and perseverance, tracing a people who refused to accept the circumstances under which the greatest majority arrived to this continent, who resisted and struggled through slavery, emancipation, Jim Crow, the modern civil rights movement, and onward through today; and

WHEREAS, 2018 marks the fiftieth anniversary of the assassination of Rev. Martin Luther King, Jr., whose vision and advocacy for human rights, and racial, economic, and social justice remain a world-wide inspiration for all peoples; and

WHEREAS, Black history is American history, and in celebration of Black History Month, we celebrate both the unique aspects of the African-American experience in this country and the remarkable contributions of African Americans to the nation and culture, so that we all may carry appreciation, understanding, and celebration, into the rest of the year; and

WHEREAS, during Black History Month, we pay tribute to the contributions and accomplishments of past generations and we reaffirm our commitment to keeping the American dream alive for generations to come, in pursuit of the righteous cause of a nation that is more just for all people, to address the inequalities and injustices that remain, and to the birthright promise of freedoms for all people that hold that all men and women are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and pursuit of Happiness.

NOW, THEREFORE, BE IT JOINTLY PROCLAIMED BY THE MAYOR AND RESOLVED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY HEIGHTS, OHIO, THAT:

<u>SECTION 1</u>. We call upon all residents of University Heights to observe the month of February 2018 with appropriate programs, ceremonies, and activities in celebration and recognition of Black History Month.

<u>SECTION 2</u>. We reaffirm our commitment to justice and against illegal discrimination in the City of University Heights, Ohio.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance of all legal requirements.
